Old Business:

1. Ordinance 2020-01 ETJ 1st Reading – Salinas handed exhibit to Commission Board of Ordinance 2020-01 ETJ for their review and consideration. McClelland asked is there are any questions or comments, none made ordinance was read - AN ORDINANCE OF THE CITY OF TIOGA ORDINANCES ESTABLISHING THE EXTRATERRITORIAL JURISDICTION OF THE CITY OF TIOGA. WHEREAS, the City of Tioga desires to establish its extraterritorial jurisdiction, through this ordinance, pursuant to Section 40-47-01.1 of the North Dakota Century Code, for certain property located within Williams County, North Dakota, which is more particularly described on Exhibits "A" and "B" attached hereto and made a part hereof. WHEREAS, the boundaries of the City of Tioga have been expanding of late due to generalized growth and certain annexations that have transpired prior to the passage of this Ordinance; and WHEREAS, it is in the best interest of the City of Tioga and in the interest of the health, safety and general welfare of the citizens of City of Tioga to adopt this ordinance so as to maximize the potential growth and development of the City and to create economical, orderly, and safe final zoning rules and regulations, which will require time, study and consideration before such other and further zoning regulations can be effectively and efficiently imposed. Chapter/Section 5 of Article 4 of the City of Tioga Ordinances is hereby amended and supplemented as follows: NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF TIOGA, NORTH DAKOTA, AS FOLLOWS: INTERIM ZONING DISTRICT PREAMBLE The City of Tioga's jurisdiction extends to all persons, places and property within its boundaries and such extraterritorial jurisdiction as is granted to the City pursuant to applicable provisions of the laws of the State of North Dakota; it was the decision of the Board of Commissioners

for the City of Tioga to avail itself of the authority granted to municipalities under Section 40-47-01.1 of the North Dakota Century Code; and The City of Tioga has a population of less 5,000 people according to the last federal census; The City of Tioga has a Planning and Zoning Commission, together with a retained engineer who have engaged in preliminary research and study that supports and suggests extraterritorial establishment is in the best interests of the City of Tioga due to the acquisition and inclusion of various properties by annexation and the growth of the City at large, which have expanded the boundaries of the City of Tioga; The City of Tioga notified the zoning board or boards of all political subdivisions losing their partial zoning authority fourteen days prior to the City's adoption of this ordinance in accordance with Section 40-47-01.1 of the North Dakota Century Code; such zoning transition meeting(s) was held on the 9th day of January, 2020, allowing the parties affected to address and review the existing rules, regulations and restrictions currently in place for the territory to be zoned and a plan was decided for the property for its orderly transition; The Zoning Commission has submitted its recommendations to the Board of City Commissioners in the form of a preliminary and final report after holding public meetings thereon recommending the expansion of the City's extraterritorial jurisdiction for exclusive jurisdiction as provided in Subsection 1(a)(1) of Section 40-47-01.1, N.D.D.C.C., and The land to be zoned and controlled by the City of Tioga is a large area where extensive planning of this magnitude necessitates intensive study of long duration before final zoning regulations can be imposed, and It is the intent of the City Commission that this interim zone classification be in all respects a zone classification no less than the other classifications heretofore enacted by this body within the Ordinance No. 2014-5, also known as Planning and Zoning 5-0401, with all amendments thereto, and Sec. 15-37. Extend the Area Covered by the Zoning Regulations. The City of Tioga hereby extends the application of its zoning regulations to include the following-described property in Williams County, North Dakota, more particularly described in the attached Exhibits "A" and "B." Exhibits "A" and "B" depict a full one-mile extraterritorial area lying beyond the corporate limits of the City. However, while the extraterritorial area described in the said Exhibits depicts a onemile extraterritorial area in total, the City shall have primary and exclusive jurisdiction for zoning regulations only within the first one-half (1/2) mile of the larger one-mile extraterritorial area described therein, meaning that such primary and exclusive jurisdiction in the City shall exist with respect the area of land commencing at the corporate limits of the City outward a distance of one-half mile. Williams County and the City of Tioga shall have joint jurisdiction within the second one-half (1/2) mile, which means that Williams County shall have and maintain primary jurisdiction within the second one-half (1/2) mile, subject to all statutory process and relief available to the City under the North Dakota Century Code and subject to any future joint powers agreement which may ultimately arise between the City and Williams County. This ordinance shall be in full force and effect upon its final passage and approval.

- Wet Lands Credit Salinas handed exhibit of email from Lonnie Fleck Engineer from Interstate Engineering firm currently working on share project with the City of Tioga for County Road 10, she advises that the City purchase wetland credits in the amount of \$24,200 for the 0.44 acers that will be impacted. Discussions held.

9. Unpaid Taxes – Salinas handed exhibit of email from Karen Prout (Williams County Attorney) Regarding 2 unsold properties in Annabelle during County Auction. The County Commission has authorized for the City to purchase those two properties in the Anabelle Homes Subdivision located in the City of Tioga which were taken by the County for unpaid taxes & special assessments. The two properties in the City of Tioga that were offered but not sold at the annual sale in November 2019 are: Lot 1, Block 64 (R) (PIN 03-000-00-19-64-010) and Lot 1, Block 54 (R) (PIN 03-000-00-19-54-010). There are also special assessments owed on both of these properties. The County Commission authorized the sale of these two properties to the City of Tioga pursuant to NDCC 57-28-19 for \$1.00. If purchased for this amount, the County Commission would then cancel the unpaid taxes and special assessments per NDCC 57-28-20.

14. Resolution 2020-02 Water Rate Increase – Salinas handed exhibit to Commission Board of Resolution 2020-02- Water Rate Increase for their review and consideration. BE IT RESOLVED, by the City Commission of the City of Tioga, William County, North Dakota: WATER AND SEWER SERVICE RATE/FEE INCREASE, EFFECTIVE March 1, 2020 RECITALS The City of Tioga, North Dakota (the "City"), a political subdivision and municipal corporation of the State of North Dakota, incorporated under the provisions of Title 40 (Municipal Government) of the North Dakota Century Code (the "NDCC"), with full power and authority to construct, repair, improve and maintain various infrastructure relating to water and sewage service within the City; and further to provide for water service within the City; and further provide sewer service within the City; and further with full power and authority to set and modify, from time to time, the rates /fees for the use and service for all of the aforementioned activities; that by Resolution the City: 1. Conducted a public hearing on February 18, 2020, which notice had properly previously been given to the public, at which time a proposed increase to the residential and commercial sewer and water rates was discussed; 2. Presented the following proposal and schedule of fees for said increase as follows: (a) Effective March 1, 2020, the fees/rate for Residential Water service within the City would not increase by way of base fee/rate in the amount of \$17.00 per month (or applicable billing cycle), but will increase by the way of an additional fee/rate of \$7.62 per every 1,000 gallons of water used during each said month (or applicable billing cycle), whereas the water current fees/rates, as of the date of hearing, was a base fee/rate of \$17.00 per month (or applicable billing cycle), together with an additional fee/rate of \$7.12 per every 1,000 gallons of water used during each said month (or applicable billing cycle); and (b) Effective March 1, 2020, the fees/rate for Commercial Water service within the City would not increase by way of a new base fee/rate in the amount of \$32.00 per month (or applicable billing cycle), but will increase by the way of an additional fee/rate of \$7.62 per every 1,000 gallons of water used during each said month (or applicable billing cycle), whereas the water current fees/rates, as of the date of hearing, was a base fee/rate of \$32.00 per month (or applicable billing cycle), together with an additional fee/rate of \$7.12 per every 1,000 gallons of water used during each said month (or applicable billing cycle); and 3. Engaged in discussion and review of the existing and proposed rates, heard any public comments made in relation thereto, and further engaged in discussion and review of various records relevant to the determination of such rates. 4. And after such discussion, review and receipt and consideration of any comments, approved the rate increase described above. BE IT RESOLVED: 5. Effective March 1, 2020 the fees/rate for Residential Water service within the City shall be a base fee/rate in the amount of \$17.00 per month (or applicable billing cycle), together with an additional fee/rate of \$7.62 per every 1,000 gallons of water used during each said month (or applicable billing cycle); Effective March 1, 2020, the fees/rate for Commercial Water service within the City shall be a base fee/rate in the amount of \$32.00 per month (or applicable billing cycle), together with an additional fee/rate of \$7.62 per every 1,000 gallons of water used during each said month (or applicable billing cycle)
