- Sundhagen: Advised Commission Board that if anyone would like to tour the construction site of the new Police Department they can as long as they stop to see the Construction Managers in the Graham Office located in the back of the construction site to give them the tour and safety equipment. Floor was handed to Police Chief Corey Murphy. Murphy advised Commission Board that a public hearing was held to hear the concerns of local citizens. The main subject that was of concern was proper lighting on highway 40 due to the increase of traffic flow, discussions held. Murphy also advised Commission Board that he is seeking Commission approval for adding 4 way stop signs on 1st and Benson.

- McClelland: Advised Commission Board that R&T is looking at increasing water rates anywhere from \$.11 cents to \$1.11 per every thousand but discussions were tabled until next meeting so they can have more information to make a determination of when and how much. McClelland also advised the Commission Board that the R&T Board elected positions will be up for elections every 2 years and his position on the R&T Board will end June of 2020, Christianson's will end in June of 2021.
