## Modifications/Approval of Agenda

- 2. <u>Temporary Crew Housing Ordinance</u> Pederson stated a lot of the zoning ordinance revision discussion would be centered around the Temporary Crew Housing ordinance and two items that Pederson said would specifically be discussed are the fees and what the fees are centered around, other items discussed was the timeframe of the permit, owner rules, and recreational vehicles. Long discussion held. A Public hearing will be held before the July meeting.

- 3. <u>Elk Creek Capital LLC, Building Application-</u> Larson handed exhibit to Planning & Zoning Board of a building permit application for the new construction of a commercial retail building for their review. - **4.** <u>Dan Larson Updates</u> Larson gave update on the concept of an industrial park housing gas/power generation and a possible aquaponics. Pine Ridge is moving forward with preliminary plat.
